Data collection	Cryo-EM data was collected using the SerialEM software package or Leginon.
Data analysis	Cryo-EM data was analyzed using Relion 3.0 or cryoSPARC v4. The structures described in the paper were built using Buccaneer and Coot, along with real space refinement in the Phenix suite. GPCR activation data was analyzed using Graphpad Prism 10. Molecular dynamics simulations were performed and analyzed using the CHARMM force field and CMAP corrections v c4621, PropKa v 3.5.0, and NAMD v 3.0.

For GPCR activation, studies were performed as three or four biological replicates, each done with multiple technical replicates. The size was chosen to obtain an accurate S.E.M. for reported values in Fig. 4 and Supp. Fig. 7.

All of the experiments in this study (GPCR activation, cryo-EM imaging) were replicated successfully multiple times. GPCR activation/inhibition studies were performed as 3-4 independent experiments (biological replicates) to ensure proper s.e.m. determination. Cryo-EM analysis was performed on >2 million particles derived from thousands of high-resolution movie stack images.

Methodology

Sample preparation

Cells were from a saturated *S. Cerevisiae* culture expressing nanobodies on the cell surface. Cells were prepared by washing with dye-free assay buffer, incubating with labeled protein, pelleting cells, discarding supernatant, resuspending in assay buffer, and injecting on instrument.

Instrument

Gating strategy

Yeast were identified by gating on FSC and SSC criteria. Cells were selected based on different cutoffs at different rounds of selection, in which the two fluorescent channels were exploited to isolate cells that bound to only CB1-5M-PGS and not PGS alone. See methods for further details.
