Data collection

Data was extracted from published studies, including experiments testing the effect of THC, observational studies assessing recreational cannabis users and studies monitoring adverse events in individuals using medicinal cannabis products.

Data analysis

All customized functions used to convert effect estimates to a common effect size (Cohen's d) are available on the study repository (https://github.com/TabeaSchoeler/TS2023_MetaCAPS). Data analysis was performed in R (version 4.3.1), using meta-analytical models to synthesize the extracted data. Fitted were random-effects models (REM) or multilevel REM models (MREM) as implemented in the R package metafor (version 4.4.0). We derived rates of cannabis-associated psychotic symptoms and the corresponding confidence intervals using the function BinomCI() and the Clopper-Pearson method as implemented in the R-package DescTools (version 0.99.52).

Sample size	163 studies (including 210,287 independent participants) were included, comprising cannabis-exposed individuals taking part in either observational (n=174,300), experimental research (n=2,009) or medicinal cannabis (n=33,502) research. Independent study participants are defined as the maximum number of participants available for an underlying study sample assessed in one or more of the included studies.
Data exclusions	We excluded studies that did not provide results to estimate rates of CAPS (i.e., the proportion of cannabis-exposed individuals reporting CAPS) or effect sizes (Cohen's d) for factors predicting cannabis-associated psychotic symptoms (CAPS). CAPS was defined as the occurrence of hallucinations, paranoia and/or delusions during cannabis intoxication.
Replication	This work synthesized the existing evidence on rates and predictors of CAPS. The level of replicability (i.e., heterogeneity) across the studies was assessed using the heterogeneity index I2.
